

These Saccades Standard Terms & Conditions (hereinafter referred to as 'SSTC') do apply to an individual user License Agreement. Each Licensee must agree and sign an individual License Agreement to obtain the Saccades Software and a Saccades License Key.

1. Definitions

Saccades Software: the software product(s) in whole or in part, as described in the individual License Agreement, including any accompanying documentation, as supplied by Cesium Software to Licensee subject to the terms and conditions of the SSTC and the License Agreement; Documentation: the description of the functionality and use of the Saccades Software provided by Cesium Software, as specified in the License Agreement ;

Licensed CPU: a computer system, consisting of a Central Processing Unit and directly connected peripherals as specified in the License Agreement;

License Key: a software key that enables Saccades Software to run on a Licensed CPU for a certain period of time;

License Agreement: the individual Saccades Software usage agreement on which these standard terms & conditions (SSTC) apply.

2. License

Cesium Software grants to Licensee a non-transferable and non-exclusive right to use the Saccades Software under the conditions and restrictions as set out herein and in the License Agreement.

3. Restriction on use

Licensee shall only use the Saccades Software, which use includes the execution of the object code, on the Licensed CPU(s). Licensee shall only use the Saccades Software on another computer system if and as long as a Licensed CPU does not function due to defects or maintenance activities. However, this use shall be for a continuous period of 30 days at the maximum and provided that Licensee will notify Cesium Software in advance of the same in writing.

When the use of the Licensed CPU is resumed, the Saccades Software should immediately be removed from the replacement computer system. The Licensee shall certify that the related licensed Saccades Software has been removed from the replacement computer system.

4. Copying

Licensee may not copy or otherwise duplicate the Saccades Software, except as necessary for the use on the Licensed CPU(s) and for back-up purposes. The latter is limited to one copy only for that particular use.

5. Modification - Reverse Engineering

Licensee shall not modify, adapt, translate, disassemble, decompile or otherwise reverse engineer the Saccades Software.

6. Credits and copyright notices

Licensee shall ensure that all markings on and in the Saccades Software indicating property right, copyright or any other title, remain thereon and therein and in and on copies (or parts) thereof.

In all advertising, publications, descriptions, packaging, labels or other public notices, in which Licensee makes mention of the use of Saccades Software, explicit reference shall be made to the rights to use the Saccades Software, granted by Cesium Software herein and by means of the License Agreement. In any case the specific wording shall be agreed with Cesium Software.

7. Non-disclosure - Transfer

Licensee shall not disclose the Saccades Software or otherwise make the Saccades Software available to any third party.

Licensee shall not transfer the Saccades Software or any data carrier on which it is stored (whether or not as a part of the Licensed CPU), nor any License Key to any third party, grant any third party any (limited) rights to the Saccades Software or grant access to any License Key. Licensee shall not disclose any information furnished in confidence to Licensee by Cesium Software concerning the methods and techniques used by Cesium Software in the Saccades Software and Licensee shall on behalf of Cesium Software impose a similar non-disclosure obligation on all its personnel and third parties it makes use of, who are acquainted with said methods and techniques.

8. Ownership

The copyrights and all other intellectual and industrial property rights for the protection of information with respect to the Saccades Software (including the methods and techniques on which it is based) that have been supplied to Licensee, or that have been reproduced by Licensee and/or merged into Licensee's programs, as well as the appurtenant documentation, shall at all times remain solely and exclusively with the original owner. Nothing herein or in the License Agreement serves to transfer such rights.

Consequently, Licensee may not sell, mortgage, sublet, lend or transfer possession of the Saccades Software in any (other) way whatsoever. The distribution media, if any, on which the Saccades Software was provided to Licensee will at all times remain the property of the Cesium Sofware.

9. Fee

Prior to execution of the License Agreement Licensee shall pay Cesium Software the Fees Payable stated in the License Agreement. The Fees shall be due within 30 days of the date of the invoice by Licensee.

10. Warranty

Cesium Software warrants to Licensee, for a period of 90 days, that the Saccades Software will perform substantially in accordance with the accompanying Documentation. This warranty period starts on the day of shipment by Cesium Software of the Saccades Software, the day the

Saccades Software was downloaded from the site indicated by Cesium Software, or, if the Saccades Software is installed by Cesium Software, starts on the last date of installation by Cesium Software.

Licensee shall report any defects found in the Saccades Software in writing and in sufficient detail to indicate the reasons for Licensee's conclusion that the defect is covered by this warranty.

Cesium Software will use any fair and reasonable effort to remedy any such defects by way of error correction or avoidance action. Cesium Software's entire liability and Licensee's exclusive remedy under any warranty or legal theory shall be replacement of the Software or return of the price paid. Cesium Software disclaims all other warranties, either express or implied including but not limited to implied warranties of merchantability and fitness for a particular purpose, with respect to the Software, and the accompanying Documentation. Except for the limited warranty provided above, the Software is provided as is.

11. Maintenance (***OPTIONAL***)

For the duration of the maintenance period as defined in the individual License Agreement, Licensee is, against payment of the applicable maintenance fee stated in the individual License Agreement, entitled to the following:

- Saccades Help Desk Support
 - o Telephone support during Dutch office hours
 - o Initial response to queries submitted via E-mail and fax within one working day
 - o Access to a WWW-based software defect database (on request)
- Saccades maintenance upgrades
 - To receive upgrades to the current functional baseline (e.g. bug fixes)

Cesium Software shall not be obliged to provide maintenance on versions of the Saccades Software Licensee uses that were released more than two years before.

12. Liability

Cesium Software shall have no liability or responsibility to Licensee with respect to any lost revenue, profit or data, or for special, indirect, consequential, incidental or punitive damages whatsoever arising out of, or in connection with the use, maintenance or inability to use the Saccades Software. Licensee shall hold Cesium Software harmless against claims from third parties against who Cesium Software cannot invoke these terms and conditions, insofar as those claims would not be admissible if those parties were to be bound by the restrictions of the SSTC and the License Agreement.

Should Cesium Software have liability on the ground of non-performance or inadequate performance of the terms and conditions herein or of the License Agreement or any other grounds, it shall at no time be bound to pay compensation greater than the fee paid by Licensee pursuant to article 9.

13. Seizure

Licensee shall inform Cesium Software forthwith of any (impending) action for distress, execution or seizure by one of Licensee's creditors and shall take all necessary steps to cause Cesium Software's right of title to be acknowledged. All costs, charges and expenses incurred in this shall be for Licensee's account.

14. Term - Termination

The SSTC and the License Agreement are effective as of the date that the License Agreement is signed by Licensee. Unless otherwise provided for in the License Agreement, the License Agreement is entered into for an unlimited period of time.

Cesium Software may terminate the License Agreement effective immediately without being required to serve notice of default upon Licensee:

• if Licensee shall fail to observe and perform the terms and conditions of the SSTC and/or the License Agreement to such an extent that Cesium Software cannot in reason be required to continue the License Agreement, such as but not limited to the situation where payment is not executed within the period mentioned in article 9;

- if Licensee shall stop using the Licensed CPU(s) listed in the Appendix(ices);
- and/or if a moratorium shall be applied for, or a petition in bankruptcy shall be filed against Licensee.

15. Consequences of termination

Should the License Agreement be terminated for any reason whatsoever, Licensee shall within 5 working days:

• stop using the Saccades Software, shall erase or destroy this software and any copies thereof, as well as the parts

thereof that are merged into Licensee's programs, and shall send Cesium Software confirmation thereof;

- return the documentation relating to the Saccades Software to Cesium Software or destroy such documentation;
- return to Cesium Software any distribution media,

subject to a fine for delay in performance of these stipulations of 10 times the list price(s) of the Saccades Software, mentioned in the License Agreement, and without prejudice to Cesium Software's right to compensation or any other remedy or sanction.

16. Audit

Cesium Software is entitled to perform audits at the premises of Licensee in order to ascertain that the obligations arising out of the SSTC and the License Agreement are complied with. Licensee shall provide Cesium Software any support or information, deemed necessary in this regard.

17. Law and differences

The SSTC and the License Agreement and the performance thereof shall be governed by the law of The Netherlands. Parties shall submit any unforeseen disputes that may arise with regard to the SSTC or the License Agreement or further agreements that may result therefrom, exclusively in the first instance to the competent judicial authority in The Hague, The Netherlands.

18. Severability

If any part, term or provision of the SSTC or the License Agreement shall be held illegal, unenforceable or in conflict with any law of a government having jurisdiction over the SSTC and/or the License Agreement, the validity of the remaining portions shall not be affected thereby.

19. Whole Agreement

Exceptions or additional provisions to this SSTC will be listed in the License Agreement and will only apply to the Saccades Software product described in that License Agreement.

The License Agreement (including the SSTC) signed by Licensee contains all the rights and obligations that each party can assert against the other in this matter. No modification, alternation or exclusion of any stipulation of the SSTC and/or the License Agreement shall be binding unless agreed in writing by both parties.

20. Authority

Licensee warrants that all persons who work with, or will otherwise have access to the Saccades Software will be notified of, and will be bound to the SSTC and the terms and conditions of the License Agreement.

Each of the signatories of the License Agreement warrants that he or she has the legal authority to bind to the SSTC and the License Agreement the party that he or she represents.
